Desegregation Lunch 12:00 – 2:00 pm Fighting Re-segregation and Promoting Desegregation – Oak Forrest Ballroom

Presiding: Gloria Sweet-Love

Session Description:

Communities have taken several approaches to promoting diversity and fighting re-segregation of schools. In Wake County, NC, the Association has fought to preserve the nation's flagship effort to integrate schools by student wealth. The NC State Conference, led by Rev. William Barber, has appealed to the Department of Education for help in a Title VI complaint. In Orland, FL, the Association ended a 48-year litigation effort by negotiating a voluntary racial desegregation agreement, despite a court ruling that could have derailed it. The local branch, led by Rev. Randolph Bracy, has sought help from DOE in reinforcing the terms of their agreement. Branches and states looking to raise student achievement by eliminating the lingering effects of segregation can learn much from these and related efforts. We will also invite comment from the Department of Justice on the issue of districts who are under court orders for desegregation.
