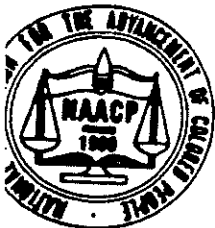

PREFACE

The NAACP has long believed that the formula for improving the legal, political and economic status of African Americans involves an equal combination of self-help, public education, legislative and grass roots advocacy, and litigation. The accomplishments of the modern civil rights movement --- beginning with the Supreme Court's decision in Brown v. Board of Education and continuing through the seminal legislative victories of the Civil Rights Act of 1964, the Voting Rights Act of 1965 and the Fair Housing Act of 1968, as well as those more recently enacted laws which extended civil rights coverage to new groups --- are an ongoing testament to the power inherent in the cause of equal justice for all.

In recent years the NAACP has again begun to rely more heavily on congressional and grassroots advocacy in pursuit of solutions to the nation's most pressing problems. In part, this is due to significant changes in the composition of the federal courts; the staunchly conservative judicial appointments during the 1980's have made the courts generally inhospitable to civil rights claims. It is also due to the changing nature of today's social conflicts, requiring an emphasis on vigorous enforcement of existing antidiscrimination laws, as well as a search for new solutions to socioeconomic problems in the African American community.

The NAACP's Legislative Report Card is a presentation of selected congressional votes taken in the 104th Congress (1995-1996) on national issues of concern to the Association. The Report Card is designed to provide NAACP members with insight into the general voting patterns of their congressional delegations. It should be considered as an educational tool in helping to evaluate the responsiveness of members of Congress to the broad interests of the African American community.

The votes selected for inclusion in the Report Card are those which have been considered on the floor of either the House or Senate. As such, the Report Card does not include legislation which may not have progressed beyond consideration by a congressional committee; nor does it provide a context to which to assess the NAACP's legislative agenda during this period.

We hope that you will find the enclosed information to be useful in your efforts to educate other NAACP members and the public about the votes of their representatives on legislation of critical importance to the African American community.

SENATE

1. **Congressional Compliance Act (S.2).** Passage of the bill to apply certain labor laws to Congressional offices, including the Fair Labor Standards Act of 1938, the Civil Rights Act of 1964, The Occupational Safety and Health Act (OSHA) of 1970, and the Family and Medical Leave Act of 1993, and to establish a separate office to oversee compliance. Passed 98-1 (Jan. 11, 1995) A "yea" vote was in support of the NAACP's position.

2. **Unfunded Mandates (S.1).** Passage of the bill to require any bill imposing costs of more than \$50 million on state and local governments to provide a Congressional Budget Office (CBO) cost analysis of the bill and specify how the proposals would be financed, or face a point of order that could be waived by a majority vote. Passed 86-10 (Jan. 27, 1995) A "nay" vote was in support of the NAACP's position.

3. **Balanced-Budget Amendment (HJRes1.)** Passage of the joint resolution to propose a constitutional amendment to balance the budget by the year 2002 or two years after ratification by three-fourths of the states, whichever is later. Three-fifths of the entire House and Senate would be required to approve deficit spending or an increase in the public debt limit. A simple majority could waive the requirement in times of war or in the face of a serious military threat. The courts would be prohibited from raising taxes or cutting spending unless specifically authorized by Congress. Rejected 65-35 (a two-thirds majority vote of those present and voting (67 in this case) is required to pass a joint resolution proposing an amendment to the Constitution. March 2, 1995. A "nay" vote was a vote in support of the NAACP's position.

4. **Self-Employed Health Insurance Deduction (H.R.831) Cloture.** Motion to limit debate on the conference report to permanently extend the tax deduction for health insurance premiums for the self-employed and to raise the deduction beginning in 1995 from 25 percent to 30 percent, offsetting the costs by eliminating the tax break for companies that sell broadcast properties to minority investors and making it harder to qualify for the earned-income tax credit by removing from the rolls individuals with more than \$2,350 in unearned income. Motion agreed to 83-0: Three-fifths of the total Senate (60) is required to invoke cloture. (Subsequently, the conference report was adopted by voice vote). April 3, 1995. A "nay" vote was in support of the NAACP's position.

5. **Fiscal 1996 Legislative Branch Appropriations/Federal Contract Awards (H.R. 1854).** This amendment was offered by Senator Phil Gramm (R-TX) to prohibit money in the bill from being used to award federal contracts based on the race, color, national origin or gender of the contractor. A "nay" vote was in support of the NAACP's position.

6. **Welfare Overhaul Conference Report (H.R.4).** Adoption of the conference report on the bill to end the entitlement status of Aid to Families with Dependent Children and some related programs and replace them with block grants to the states; to give states wide flexibility to design their own welfare programs; to require welfare recipients to engage in work activities after receiving cash benefits for two years and limit benefits, in most cases, to five years; to give states option to deny cash benefits to unwed mothers under age 18; to deny most benefits to legal and illegal immigrants, etc. Adopted 52-47. Dec. 22, 1995. A "nay" vote was in support of the NAACP's position.

7. **Fiscal 1996 VA-HUD Appropriations - Passage of the bill to provide about \$81 billion in fiscal 1996 budget authority for Veterans Affairs, Housing and Urban Development, and independent agencies. The bill provided about \$8.9 billion less than the Administration requested and from what was provided in fiscal 1995. Passed 55-45 (Sept. 27, 1995). A "nay" vote was a vote in support of the NAACP's position.**

8. **Product Liability (S.565; passed as H.R. 956). The conference report would rewrite rules governing product liability suits in federal and state courts, placing caps on punitive damages. The bill would cap damages against small businesses at a maximum of \$250,000. Damage awards against other companies could go higher. Provisions that would limit medical malpractice liability and shield the makers of medical devices and drugs were not included in the report. The Senate adopted the conference report on March 21, 1996. A "nay" vote was in support of the NAACP's position.**

9. **Anti-terrorism and Effective Death Penalty Act of 1996 (S.735). Adoption of the conference report would expand federal power to prosecute and punish certain crimes related to terrorism, require that tracing materials be added to plastic explosives and make it easier to turn away undocumented foreigners who arrive seeking asylum. It would also add restrictions on federal appeals by death row prisoners and others. The legislation would authorize \$1 billion over four years for federal counterterrorism efforts, possibly to be taken from the \$30.2 billion trust fund created in the 1994 crime bill. Report adopted by the Senate on April 17, 1996. A "nay" vote was in support of the NAACP's position.**

10. **Health Insurance Reform (S.1028). The bill aims to make it easier for workers to keep insurance coverage if they lose or leave jobs. It would generally require group insurance plans to offer coverage to all employers and their employees and dependents, regardless of pre-existing medical conditions or medical history. The Senate bill does not contain a provision authorizing medical savings accounts. The bill passed the Senate on April 23, 1996. A "yea" vote was in support of the NAACP's position.**

HOUSE

1. **HR1. Congressional Compliance - Passage.** Passage of the bill to apply certain labor laws to congressional offices, including the Fair Labor Standards Act of 1938, the Civil Rights Act of 1964, the Occupational Safety and Health Act of 1970, and the Family and Medical Leave Act of 1993, and to establish a separate office to oversee compliance. A "yea" vote was in support of the NAACP's position.

2. **HJResl. Balanced-Budget Amendment - Passage.** Passage of the joint resolution to propose a constitutional amendment to balance the budget by the year 2002 or two years after ratification by three-fourths of the states, whichever is later. Under the proposal three-fifths of the entire House and Senate would be required to approve deficit spending or an increase in the public debt limit. A simple majority could waive the requirement in times of war or in the face of a serious military threat. A "nay" vote was in support of the NAACP's position.

3. **HR5. Unfunded Mandates - Passage.** Passage of the bill to require any bill imposing costs of more than \$50 million on state and local governments to provide a Congressional Budget Office cost analysis of the bill and specify how the proposals would be financed, or face a point of order that could be waived by a majority vote. A "nay" vote was in support of the NAACP's position.

4. **1995 CQ House Vote 150 (H.R. 831). Self-Employed Health Insurance Deduction - Passage.** Passage of the bill to make permanent the 25 percent tax deduction for health insurance premiums for the self-employed and to offset the costs by eliminating the tax break for companies that sell broadcast facilities and cable TV systems to minority investors. The health deduction would be retroactive after Dec. 31, 1993, and the repeal of the minority broadcast preference would be retroactive from Jan. 17, 1995. A "nay" vote was in support of the NAACP's position.

5. **1995 CQ House Vote 607 (H.R. 2099). Fiscal 1996 VA-HUD Appropriations - Passage.** Passage of the bill to provide \$79.4 billion in new budget authority for fiscal 1996 for the departments of Veterans Affairs and Housing and Urban Development and certain independent agencies. The bill would provide \$10.5 billion less than the fiscal 1995 level of \$89.9 billion and \$10.5 billion less than the administration request of \$89.9 billion. A "nay" vote was in support of the NAACP's position.

6. **H.R. 2259. Sentencing Guidelines - Passage.** Passage of the bill to reject the advice of the U.S. Sentencing Commission and retain stringent sentencing guidelines for crack cocaine and money laundering offenses. The commission's guideline of crack cocaine would address a disparity in penalties between crack and powder cocaine. A "nay" vote was in support of the NAACP's position.

7. HJRes15. Fiscal 1996 Continuing Resolution - Passage. Passage of the joint resolution to provide continuing appropriations through Dec. 1, 1995, for fiscal 1996 spending bills not yet enacted. The continuing resolution would require that program spending be set at the lowest of the levels in the fiscal 1995 bill, the House-passed 1996 bill or the Senate-passed 1996 bill. Programs could continue at a maximum of 60 percent of their 1995 levels if the House and Senate had voted to cut them more deeply than that or to terminate them. The resolution contains provisions that would bar furloughs of federal employees and limit lobbying or political advocacy by organizations that received federal grants. A "nay" vote was in support of the NAACP's position.

8. H.R. 2076. Fiscal 1996 Commerce, Justice State Appropriations - Passage. Passage of the bill to provide \$27.06 billion in new budget authority for the departments of Commerce, Justice and State, the judiciary and certain independent agencies for fiscal 1996. The bill would provide \$725.2 million more than the fiscal 1995 level of \$26.9 billion and \$3.6 billion less than the administration request of \$31.2 billion. A "nay" vote was in support of the NAACP's position.

9. H.R. 4. Welfare Overhaul - Conference Report. Adoption of the conference report on the bill to end the entitlement status of Aid to Families with Dependent Children and some related programs and replace them with block grants to the states; to give states wide flexibility to design their own welfare programs; to require welfare recipients to engage in work activities after receiving cash benefits for two years and limit benefits, in most cases, to five years; to give states the option to deny cash benefits to unwed mother under age 18; to deny most benefits to legal and illegal immigrants; to reduce federal spending on the food stamp program; to further restrict eligibility for Supplemental Security Income; to require states to adopt laws that would withhold driver's licenses, professional and occupational licenses, and recreational licenses of parents who fail to pay child support; and for other purposes.

10. Health Insurance Reform (H.R. 3103). This bill aims to make it easier for workers to keep health insurance if they lose or leave jobs. This version contains medical savings accounts (MSAs), which are tax-preferred savings accounts that employers would set up for workers to help defray medical expenses. MSAs could siphon off healthier, wealthier persons, making coverage even costlier for those left in the rest of the system - low-income, unhealthy persons. The NAACP opposed this measure because it included the MSAs. It passed on March 28, 1996. A "nay" vote was in support of the NAACP's position.

11. Minimum Wage Increase (H.R. 3448). This bill would increase the hourly minimum wage by 90 cents, from \$4.25 to \$5.15, over two years. It passed on May 22, 1996. A "yea" vote was in support of the NAACP's position.

The report maintains the federal school lunch program but also establishes a new block grant demonstration program to allow up to seven states to control their own school lunch and breakfast programs. A "nay" vote was in support of the NAACP's position.
